In-depth Character Analysis: The Junk Seller, Kiran, is resourceful and resilient. She finds a business opportunity in selling junk and faces societal stereotypes bravely, demonstrating her strength and determination.

Maths Challenge: Total cost = Cost per item × Number of items = ₹2 × 4 = ₹8. Total revenue = Selling price per item × Number of items = ₹4 × 4 = ₹16.

Answer: Total cost = ₹8, Total revenue = ₹16
